I began my arbitration training in 2007. Over the course of the last nine years, I have served, or I am currently serving as an arbitrator in more than fifty arbitrations. I am on the Energy Panel for the AAA as well as the newly created Appellate Arbitration Panel. I also serve on the Commercial and Large Case Panels. The matters where I have served have been both with associations and self-administered, and I have worked in domestic and international arbitrations under JWA, AAA, ICC, CPR, ICDR, UNCITRAL, IBA, and CIArb, the Chartered Institute of Arbitrators, rules. I have also served as a FINRA arbitrator.

In 2015, I was honored to be elected to the Hall of Fame for Chief Justices of State Courts of Appeal by the National Center for State Courts in Williamsburg, Virginia. My varied practice before taking the bench, my experience on the bench, and my experience upon returning to the practice of law, most of which have involved energy issues, uniquely qualifies me to serve as an arbitrator. Additionally, I have a unique qualification of having served on panels of three deciding disputes for over twenty years.

Working for the federal District Courts of Texas, I have successfully mediated cases as diverse as trade mark infringement, theft of business secrets and opportunities, product defects, personal injury, minority shareholder actions, and medical insurance coverage claims.

Background:

As background for the litigants, I practiced law in Abilene, Texas specializing in banking, oil and gas and energy business litigation before being appointed to the appellate court in 1986. I represented major oil companies, independent operators, exploration companies, drilling companies, pipeline companies, oil marketing and trading companies, oil field

servicing companies, refineries, a public utility, financial institutions, and investors. I performed title searches and prepared Drill Site Title Opinions and Title Opinions for distribution of royalties and leasehold interests. I represented Texas companies with foreign oil concessions. I performed due diligence searches in multimillion-dollar energy transactions, formed business entities, complex debt structuring, as well as all aspects of court appearances including representing debtors and creditors in bankruptcies. I represented clients before price regulating commissions.

I served for over twenty years on the bench before retiring from the 11th Court of Appeals of Texas. While on the bench, I presided over approximately 6,000 appeals. These cases represented every possible aspect of the procedural and substantive law. Many cases involved in the oil, gas and mineral legal issues because of the geographic area of the court. Most are reported in the South Western Reporters.

Before opening my private practice in Houston, I was a partner and Co-Chair of the Winstead Appellate Section for three years. Because of my extensive judicial experience, I have served as an appellate lawyer to Fortune 500 companies as well as individuals. As an appellate attorney, I have served as lead counsel, presenting oral arguments to intermediate appellate courts in Texas as well as the U.S. Fifth Circuit, the Texas Supreme Court and the Louisiana Supreme Court.

Appellate Legal Practice Since Retiring from The Bench:

Federal Appellate Courts:

- 1. United States Court of Appeals for the Federal District No. 2008-1332, *Clock Spring, LP,v. Wrapmaster et al.*
 - This was a significant case in that I was able to invalidate a prior patent and the Federal District Court of Appeals designated this case as precedential. This patent involved repairing pipe lines in place by wrapping the pipe with a fiber carbon sleeve and epoxy thereby decreasing the amount of down time needed to repair leaks.
- 2. United States Court of Appeals for the Fifth Circuit No. SA-04-CA-303-XR, *Stephen R. Smith v. BCE, Inc.*This case was based on fraud in the inducement. Smith traded his interest in a telecommunication business, ExCel, to Canadian Bell for an interest in a Bell subsidiary.
- 3. United States Court of Appeals for the Fifth Circuit No. 05-20960, John Lozano v. Owen Federal Land Bank.

 This case involved land issues and mortgage foreclosure by a homeowner who had claimed that he had paid the mortgage twenty years before.
- 4. United States Supreme Court Martha Holt Dimick, *Chairperson*, *Minnesota Board on Judicial Standards*, et al., v. Republican Party of Texas, No. 05-566.

Amicus Brief filed on behalf of the American Judicature Society. This case involved Judicial Canons placing restrictions on campaign speech by judges running for office.

State Appellate Courts:

- 1. Supreme Court of Texas, *The State Of Texas v. Charles Lynn Brownlow And Marlene H. Brownlow*, No. 08-0551. This case was affirmed on behalf of my client.
- 2. Texas Court of Appeals for the 5th District, Dallas, *American Title v. Bomarc*, No. 06-0789-cv.
 - This case involved a "property flip." I briefed and presented oral argument as well the response to a writ of petition which was denied by the Texas Supreme Court.
- 3. Texas Court of Appeals for the 14th District, Houston, *In re Russell Reichert, et al*, No. 14-08- 00870-cv.

 This case was presented by writ of mandamus and involved an interesting and undecided issue between competing jurisdictions of trial courts. Pleadings were filed in one county electronically and subsequently the next morning by opposing party in another county.
- 4. Texas Court of Appeals for the 1st District, *Houston, Russell Scott Clark, et al. v. Wells Fargo Bank*, et al., No. 01-08-00887-cv. This case involves an issue of the bank's liability for negligence in setting up "payable on death" accounts. Affirmed on behalf of my client.
- 5. Texas Court of Appeals for the 5th District, Dallas, U.S. Bank, National Association, As Trustee and Orix Capital Markets, LLC v. American Realty Trust, Inc. No. 05-07-00328-cv.

 This case involved an issue of whether a "trade name" being intangible property can be wasted the same as real property.
- 6. Texas Court of Appeals for the 3rd District, Austin, *Linda Cloud v. Mike McKinney et al*, No. 03-04-00656-cv.

We became involved at the motion for rehearing stage and successfully encouraged the court to alter its opinion. This case has far reaching implications for the law of official immunity.

- 7. Texas Court of Appeals for the 3rd District, Austin, *Levy, et al.*, *v. office Max, et al.*, No. 03-06-00391-cv.

 This was an appeal from the non-certification of a class action.
- 8. Texas Court of Appeals for the 14th District, Houston, *Solvent Underwriters v. Furmanite America*, No. 14-07-00889-cv.

 This case is a significant decision in policy insurance contract interpretation involving "claims made" versus "occurrence" provisions.
- 9. Texas Court of Appeals for the 1st District, Houston, *Merenco Realty v. Mobil Producing*, No. 01-08-00401-cv.

 This case involved a significant and undecided issue in the rights of a co-owner to demand a partition of lands thereby negating covenants and obligations for environmental cleanup operations.
- 10. Texas Court of Appeals for the 10th District, Waco, MCI Sales and Service, Inc., et al. v. James Hinton, Individually and as Representative of the Estate of Dolores Hinton, Deceased, et al, No. 10-06-00256-cv. I argued case in the Waco Court of Appeals as well as made presentations in the federal Bankruptcy court. This is a manufacturing defect case against a passenger bus manufacture for failure to install seat belts.
- 11. Texas Court of Appeals for the 1st District, Houston, *Poretto v. General Land Office*, No. 01-05-00942-cv.

 This case involved the issue of whether the State of Texas by its voluntary participation in mediation and the subsequent execution of a settlement agreement waived its sovereign immunity. We filed this *amicus* brief on behalf of the Association of Attorney-Mediators.
- Supreme Court of Texas, Exxon Corporation v. Emerald Oil and Gas, et al., No. 05-1076.
 This case involves the proper damage model for damages to the well bore in plugging procedures. We filed this amicus brief on behalf of the North Texas Alliance, an organization of independent oil operators.

- 13. Texas Court of Appeals for the 3rd District, Austin, *Attilla Horvath v. Julie Hagey*, No. 03-09-00056-cv.

 This is a marital property dispute involving the sale of a power plant in Hungary.
- 14. In the Texas Court of Appeals, for the 14th District, Houston, *In Re TCW Global Project Fund II, Ltd., TCW Asset Management Company, and Trust Company of the West*, No. 14-08-00116-cv. This case involved the issue of forum selection on a drilling contract to be governed by English law.
- 15. Supreme Court of Texas, *Office of Public utilities Counsel, et al. v. Public Utility Commission*, No. 08-727. This case involved 800 million dollars owing and to be recouped by the various utility companies after deregulation of the sale of electricity in Texas.

This body of work is an indication of the variety and complexity of the work I handled since returning to private practice.
