FDIC*, 315 U.S. 447 (1942) and borrower had truthfully completed loan form, but additional finding that borrower leant himself to scheme to defraud negated borrower’s use of homestead exemption from lien claim)
- *In re Four Sevens Oil Co.*, No. 05-08-00768-CV, 2008 WL 2764506 (Tex. App.—Dallas 2008, orig. proceeding) (mandamus standard not met re denial of venue transfer)

- *In re Gulf Coast Bus. Dev. Corp.*, 247 S.W.3d 787, 794 (Tex. App.—Dallas 2008) (trial court's discretion to consolidate cases limited if prejudice results)
- *Gulf Coast Bus. Dev. Corp. v. Texas Hematology/Oncology Center, P.A.*, No. 05-07-01593-CV (Tex. App. - Dallas 2008) (appeal of injunction of eviction case while dispute about leasehold rights pending)
- *Methodist Hosps. of Dallas v. Miller*, 405 S.W.3d 101 (Tex. App.—Dallas 2012 no pet.) (commissioned officers did not prove they were private peace officers within meaning of Tex. Educ.
